A(ii)(a) "A fee of Rs. 10/-(Rupees ten) only shall be charged in favour of all cases for restoration of mortgaged/auctioned land to the borrower members i.e farmers on clearance of the entire due amount to the bank on the instruments of conveyance/sale deed executed in favour of the following farmers of H.P:-
